

Privacy Statement

This privacy statement sets out how Nexus uses and protects any information that you give Nexus when you join the Nexus Insight Panel. Full details on joining the Insight Panel are available in our FAQ's available at nexus.org.uk.

Nexus is committed to ensuring that your privacy is protected. Information by which you can be identified when completing a survey will only be used in accordance with this privacy statement.

Nexus may change this statement from time to time by updating this page. You should check this page from time to time to ensure that you are happy with any changes. Panel members will be informed when this statement is updated in the next survey invite.

This policy is effective from 13th June 2019.

Information (collection, use and disposal)

We take the protection of the personal information that you submit to us seriously. Nexus collects information from our Nexus Insight Panel members in various ways, governed by the law of England and Wales.

We anonymise and aggregate all responses to our surveys so that results cannot be related to an individual's responses. Responses and results are stored on secure Nexus Servers.

We will not sell, distribute or lease your personal information to third parties unless we have your permission or are required by law to do so. We will use your personal information to send you monthly surveys if you have opted to receive future surveys. Invitations to complete Insight Panel surveys will always be by email.

Your responses to surveys are not personal information and will be aggregated to produce summary statistics. Nexus may use comments you have provided as part of the surveys without restriction and will be the exclusive property of Nexus from the point at which you submit your survey but these comments will be anonymised. You have the right to ask us not to process your personal data for the purposes listed in this document. You can exercise your right to prevent such processing by checking certain boxes on the forms we use to collect your data. Registration information

- Nexus will collect profile information and your email address during the registration process.
- Profile information will consist of year of birth, sex, ethnicity, employment status, postcode, email address, any disabilities and travel habits. This information is collected to avoid us having to ask you the same questions on all surveys and to add context to survey responses.
- Nexus will periodically invite you to update your profile information.
- The information is collected using SurveyMonkey™
- Profile information will be securely stored for the length of your panel membership and shall be kept for no longer than is necessary for the purpose for which it is being processed. If you leave the panel all profile information will be deleted.

Survey responses

- Survey responses will be collected by Nexus using SurveyMonkey™ on a monthly basis.
- Your survey responses are matched to your profile information and then anonymized.
- All survey responses are anonymized to remove all links to an individual's identity.
- Survey responses are analysed to produce aggregated results.

Prize Draw entry information

- Nexus will collect Prize Draw entry information when a survey respondent opts into a Prize Draw.
- This information consist of name, postcode and email address.
- Prize Draw entry information will be kept until the prize for the draw has been collected.
- Prize Draw entry information of Prize Draw winners will be kept for a period of 2 Years from the date the prize was collected.
- Prize Draw entry information will be used to contact Prize Draw winners, to maintain a record of winners for internal audit purposes and to announce Prize Draw winners names on nexus.org.uk
